#### <u>ITEM 7</u> **2017/2018 ASSET MANAGEMENT PASER REPORT**

Ms. DeOliveira noted that the 2017/2018 Asset Management PASER report has been completed and is available online. The report covers the Region 2 Planning Commission tri-county area of Hillsdale, Jackson, and Lenawee counties. The PASER information was sent to all of the communities that collected the data, along with TAMC, the state agency that collects and houses the information for communities across the state.

### <u>JACTS FY 2020 – 2023 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)</u> <u>UPDATE</u>

Ms. DeOliveira reported that the JACTS TIP subcommittee met in January to discuss and reprogram STP funds previously awarded to JCDOT for the reconstruction of McDevitt Avenue in FY 2022 and 2023. JCDOT recently was notified they received \$3.8 million in state funding to reconstruct McDevitt Avenue in FY 2019. The subcommittee reprogrammed the available funding for road projects on South St. in FY 2022, Badgley Road in FY 2023, and Brown St project in 2023.

#### ITEM 9 JOINT CITY / COUNTY NON-MOTORIZED PLAN UPDATE

Ms. DeOliveira stated that the Project Steering Committee Kickoff meeting was held Friday, February 15. The consultants provided an introduction to the project and asked members to talk about their hopes and concerns for the plan. A round of countywide public meetings will be held later this spring offering an opportunity to provide input into the project during the initial development phase. A project website will also be forthcoming to keep the community and committee members informed as the project progresses.

#### ITEM 10 OTHER BUSINESS

Mr. Davis gave a brief update on the 5-Year Transportation Alternatives Program (TAP) report. All of Michigan's 83 counties are competing for this money. The combined City of Jackson and Jackson County Non-Motorized Plan could potentially help bring more TAP money to the Jackson area. Having a non-motorized plan is important in having a project receive TAP funding.

The project was in the MDOT July letting with Bailey Excavating as the low bidder. The area around the roundabout is complete. The project has shut down for the winter with the West Ave and Fourth Street roundabout and the remainder of the paving to be finished next spring with a start date of June 3, 2019 after the Rose Parade on Fourth Street.

<u>Fourth Street and Horton Intersection (Urban)</u> – Intersection realignment and new Traffic Signal. HRC is the City's consultant. The project was in the MDOT August letting with Hoffman as the low bidder. The start date will be on June 3, 2019 after the Rose Parade on Fourth Street.
