A. Consideration of Township Zoning Amendment(s).

1. CZ24-19 Petition for Rezoning

Columbia Charter Township

Columbia Charter Township submitted a petition to rezone a 2.2-acre parcel located at 10405 Brooklyn Road from Agricultural (AG) to General Commercial (C-2). The property, which currently has a vacant 13,000-square-foot building and paved parking area, was previously used as an automobile dealership but has been unused for over two years. The proposed rezoning aims to facilitate its development for commercial purposes, although no specific use has been stated in the application.

Staff recommended approval with comments, as per the conditions outlined in the Region 2 staff report (included in the meeting packet). These conditions aim to ensure that any future commercial use of the site does not further

contaminate the property and include prevention and mitigation measures for any unexpected occurrences, such as the submission of an environmental protection plan and adherence to EGLE guidelines.

Commissioners discussed the petition, potential future uses of the site, and possible contamination measures that could be implemented. Commissioner Minnick added that he had reached out to the applicant prior to the meeting, and the property owner was very amenable and forthcoming about his intentions to sell the property, his awareness of the contamination on site, and the restrictive covenant.

Vice Chairperson Kennedy made a motion to approve with comment, the proposed rezoning petition from Columbia Charter Township, seconded my Commissioner Cole. MOTION UNANIMOUS
